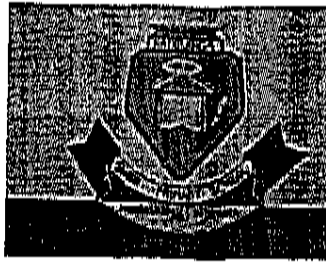

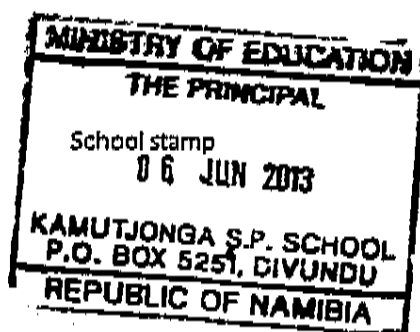
Furthermore keep up assisting us so that teaching and learning may prosper at this school.

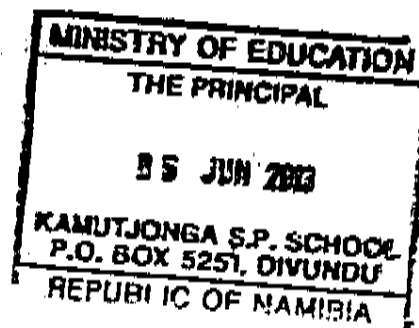

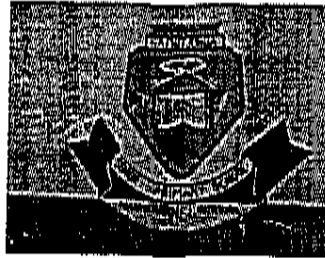
